
- Lead by example and according to our values and policies

Carsten Sommerhage

Prior to joining Schoeller Holdings as Mr Schoeller's personal assistant in 1996, Carsten Sommerhage sailed the seas on various types of cargo vessels, worked for the Institute of Ship handling, Maritime Traffic and Simulation (ISSUS) in Hamburg and for Atlas Elektronik in Japan. In 1997 the Master Mariner came back to Germany to develop COLUMBIA's ship management office in Hamburg, an assignment he is in charge of ever since.

Phivos Vakis

Having graduated at the London School of Economics with a BSc in Econometrics and Mathematical Economics, Phivos Vakis started his career at Deloitte's and qualified as Chartered Accountant in 1988. In 1989 he returned to Cyprus to work for KPMG as manager in the audit department. In 1990 he joined COLUMBIA Shipmanagement and Schoeller Holdings and was appointed Group Finance Director in 1992, a position he still holds today.

Maurice Baker

The Glasgow College of Nautical Studies graduate sailed the seas and climbed the ranks to finally qualify as Master Mariner. In 1995 his first shore job as ship manager led him back to Glasgow and later to London. Here he continued studying to become a member of the Institute of Chartered Ship Brokers. In 1999 he joined CSM in Cyprus as Operations Manager and was appointed Marine & Operations Director in 2007. In 2014 Mr Baker was appointed Managing Director.

Axel Schulz

According to his own words Axel Schulz spent all his life in shipping and shipbuilding. He holds a Master Degree in Ship and Energy Machinery Engineering and sailed the seas for years on various types of vessels. Before joining CSM in 2015 as Technical Director he held different management positions at German shipyards for 17 years, with the focus widening from the technical side to sales and general management.

Christis Angelides

Holding degrees as Dipl.-Ing., Mechanical Engineer and Naval Architect, Christis Angelides joined CSM in 2007 after serving for almost 20 years as principal surveyor, lead auditor, trainer and country manager with Germanischer Lloyd classification society. He took over the position of Deputy Director for New Buildings & Projects. In 2011 he moved to Schoeller Holdings to become Director for Management Systems.

Andreas Hadjipetrou

The BSc in Economics and MBA in Total Quality Management joined the company 20 years ago. He held various positions within the Cyprus office before he moved to CSM's Hamburg office in 2006 to take over the role of Financial Director. He also sits on the Board of Directors of the Cyprus Shipping Chamber.

During his more than 20 years in shipping Mads Soerensen's primary focus was on the accounting side of the business, the secondary on IT and systems. The BSc in Accounting started his career at A.P. Moeller/Mærsk where he held various positions. He then became Finance Director at XPonCard and CFO at MSC Scandinavia Holding and TeamLines. In 2011 he joined CSM to succeed Andreas Hadjipetrou as Financial Director in Hamburg.

uilding on CSM's strengths, streamlining operations, harmonising systems and improving efficiency – four cornerstones of COLUMBIA's strategy to meet the challenges lying ahead. Monitored by its Chairman, Mr Heinrich Schoeller, COLUMBIA's new Management Board will take the required and appropriate measures to implement respective decisions within the CSM Group of Companies.

"There is so much valuable expertise in all COLUMBIA companies that we have to make sure everybody can benefit from it", says Mr Schoeller. "We have to make it easily accessible for all. This will be one of the main objectives of our Group Directors. I have seen other companies where offices in different countries were competing with each other instead of co-operating. This will not happen at COLUMBIA. At the end of the day it does not matter whether services are provided from Cyprus, Hamburg, Shanghai or Singapore. The most important thing is they are provided by COLUMBIA. We are one company."

Working relationships

Closely co-operating with other companies sharing similar ethics and values will also become more important in the years to come. "The multi-purpose co-operation AAL has launched last year with Hamburg-based Peter Döhle Group can serve as a blue-print", explains Mr Schoeller. "Both companies will share their experience, resources and hardware across the world to offer joint Tramp & Project services – but they will remain independent of one another."

Crewing – including training – is one of the areas where co-operation pays off as well. It started with Peter Döhle in Poland, Russia and the Ukraine. The training academy of Tsakos Columbia Shipmanagement was launched in Athens in 2013. In 2015 COLUMBIA joined forces with REEDEREI NSB to recruit seafarers in

Eastern European countries and the Philippines. Furthermore, COLUMBIA will extend its existing seafarer training co-operation with Marlow Navigation, a Cyprus-based shipmanagement company, to include shore based training in future.

Marlow Navigation also is a joint venture partner of a newly formed IT-company that will develop tailor-made software and IT-systems for both companies.

"To take advantage of economies of scale we're thinking about strategic alliances in all departments - be it maintenance, purchasing, accounting or travel", states Mr Schoeller.

COLUMBIA Cruise Services is set to grow

"If you look at all the cruise operators that now have their headquarters or offices in Hamburg, then it is quite obvious that this city will become Europe's cruise centre. To best meet the demands of this growing industry, COLUMBIA Cruise Services in Hamburg will grow in terms of manpower and areas of responsibility", says Mr Schoeller.

"Shipmanagement is in our genes"

Mr Schoeller started his shipping career in 1959 and since then has weathered many storms. Everything that happens has happened before – at least once.

"Having a fleet of own vessels can be a two-sided sword in these volatile times", states Mr Schoeller. "But is has a distinct advantage. Our clients recognise that we look at shipmanagement also from an owner's point of view: An owner cares for his vessels. In addition they don't consider us as competitors as we only own and operate feeder sized vessels between 1200-2800 TEU and product tankers. What matters most for our clients are our competence and our experience."
